### **FACT SHEET**

## CHOOSE NORMANDY LEARN FRENCH STAY SAFE

### **STAFF**

Everyone entering the school MUST immediately sanitise their hands

Each class room is equipped with sanitiser for regular use and tissues for single use

Staff must all be in the school at least 30 minutes before their class starts as classes may have to be given at staggered intervals

Staff must wear a mask on public transport to and from the school and wear an approved mask AFNOR Category 1 in the school and in lessons.

Staff will be responsible for keeping windows open and airing the rooms (shutters may be closed if windy, wet etc) and for closing them after the lessons.

Staff are responsible for their own personnel named equipment which must not be shared and must be sanitised twice daily

Staff will be responsible for sanitising equipment used in class ie Bluetooth keyboards/tv commands etc.

Staff are responsible for ensuring that students stick to the designated pathways, ensuring that staggered coffee breaks are respected and that students do not congregate in groups of more than 10.

Staff are responsible for themselves and their students in respecting the 1 metre/social distancing rule at all times.

Staff are responsible for washing up their own plates/cups...anything left will be removed.

# **STUDENTS**

Everyone entering the school MUST immediately sanitise their hands

Visitors must give their name. address and telephone number in the case that we need to track and trace.

Each class room is equipped with sanitiser for regular use and tissues for single use

Students must all be in the school at the time given and may only enter up to 60 minutes after their class starts as classes may have to be given at staggered intervals

Students are responsible for their own personnel named equipment which must not be shared and musts be kept clean and sanitised daily

Students must come to French in Normandy equipped with their own face protection- AFNOR masks are available in the school for students @ 2euros.

Students agree to stick to the designated pathways, ensuring that staggered coffee breaks are respected and that they do not congregate in groups of more than 10.

Students are responsible for their health and safety, that of other students and that of our staff in respecting the 2 metre/social distancing rule at all times.

For both staff and students smoking or the use of electronic cigarettes is NOT permitted in or near the school to avoid groupings.

Students arriving from Europe need a test 72 hours before departure and then we ask for a repeat test on the first Tuesday to ensure that they are still negative and again on the first Friday. In the case

of a positive test they must self-isolate and their lessons will be online for the required period. The chemist next door to the school can do these tests which cost 25 euros each.

The school is cleaned and disinfected daily and is well aired morning and afternoon. Distances are respected in classes.

Anyone breaking these rules will not be allowed entrance to the school and no refunds will be given.

### **GENERAL INFORMATION**

There is a curfew in place throughout France for 19h-6am. This will remain in force until 19/05 when it will be extended to 21h. The curfew will be further extended to 23h on the 09/06 and if the situation permits will be abolished on the 30/06.

Public transport is running normally but we suggest that students take out a subscription for a city bike and keep it so that they know it is sanitized for their own personal use.

We are allowing students to keep bikes in a classroom at the moment.

Café and terrasses outside will be open if all goes well from the 19/05 and from the 09/06 inside restaurants, cafes, museums etc.

**PASS** 

From the 09/06 people will need a certificate of vaccination or a PCR test to attend events such as football matches etc

ALL SHOPS WILL BE OPEN FROM THE 19/05 IN ROUEN

Shops open right now:

Florists/specialised chocolate shops/Bakers/Cake shops

Garages and car dealers

Stationery/Record, disc, books and music shops

Repair shops for shoes, computers, telephones etc

Opticians/Garden centres

Estate agents, lawyers

Supermarkets and all food shops/Fast food, takeaways, sandwicheries etc

NB From April 18<sup>th</sup> all student arriving from Brazil/Guyana/South Africa and Chile will be require to quarantine for ten days in a declared address ie a Host Family. No new visas even long term will be given until further notice for these countries. Students from outside the EU will need to fill in these forms;
